# Legal advice in case of accident, incident or operating irregularity

## **CAUTION**

These are general guidelines; they may not be applicable in every situation. Individual discretion, and decisions contrary to these guidelines, may be required in some situations.

***IN THE EVENT OF CONFLICT BETWEEN THIS GUIDANCE AND YOUR COMPANY GUIDANCE, YOUR COMPANY GUIDANCE TAKES PRECEDENCE***

You are ALWAYS subject to the laws of the country that you are in, NOT the laws of your country of residence or citizenship. In the event of an accident, incident or operating irregularity, you may be questioned or even detained by the local authorities. You may also be subject to enforcement and/or disciplinary action(s) by the local government and/or your employer.

To minimize the likelihood of adverse consequences, the guidance below should be followed to the extent possible. In certain cases, the best course of action may be to discreetly leave the country as soon as possible.

1. Once you are assured that the immediate needs of your passengers and fellow crew members are being met, attempt to contact your company, your Association or IFALPA.

2. If assistance is needed, and you cannot reach your company, your Association, IFALPA, or an IFALPA Member Association (MA), attempt to contact your Embassy or Consulate.
3. Attempt to obtain rest facilities away from the airport for all crew members. (One option is to request hospitalisation)
4. If you are prevented from contacting any source of assistance, or from moving the crew to a hotel or medical facility:
  - Attempt to keep your crew together, and advise them all of the relevant information.
  - Adopt and present a cooperative demeanour.
  - Only if requested, provide your certificate to any authority (transportation, law enforcement, etc) for examination.
  - Do not allow any authority to permanently retain any certificate.
  - Only if requested, provide oral or written statements.
  - Use the sample statement (following page) if possible.
  - Keep your responses brief, factual and to the point.
  - Avoid conjecture, hindsight or judgment.
  - Make or retain copies of all documents relating to your flight.
  - Keep these, along with any personal notes, to yourself.
  - Do not make any statements to the media.

Experience has shown that it is frequently valuable to make an aircraft log book entry, regardless of how inconsequential or obvious the event may appear to be at the time.

Normally, Company officials are responsible for notifying the appropriate authorities of an accident or incident.

You should notify State authorities directly of an accident or incident ONLY IF the State mandates that YOU report the event. These States are identified in this document.
